



Terms of Reference (ToR)

Developing guideline for Vietnamese cities to fulfill their COP26 commitments on green and low-carbon urban development

I. Background

Currently, climate change has been a serious global challenge and Vietnam is one of the developing countries heavily impacted by climate change. At COP26, Vietnam has made strong commitments with nearly 150 countries to bring net emissions to "zero" by the middle of the century; together with more than 100 countries, Vietnam has committed to reduce Global Methane Emissions by 2030 and has with 48 countries to join the Global Declaration on the transition of coal power to clean energy, etc. The implementation of commitments at COP26, especially the commitment to bring net emissions to "zero" by mid-century is an inevitable and irreversible trend; thus, the timely implementation of these commitments will bring great and long-term benefits to Vietnam.

The focus of this task is to assess the possibility of developing green and low-carbon cities in Vietnam, thereby guiding cities to develop roadmaps and action plans to fulfill Vietnam's commitments at COP26 on developing low-carbon cities towards net zero emissions by 2050. This is a key area as well as a key to sustainable urban development in Vietnam.

Against this background, the project Climate and Energy in Asia of the Friedrich-Ebert-Stiftung (FES) and The Academy of Managers for Construction and Cities (AMC) are seeking consultant(s) to work with us on developing a guideline/framework for cities to achieve net zero target.

II. Scope of work

The consultant(s) will work independently in consultation with FES and AMC to contribute to the development of guideline for cities to achieve net zero target. The consultant(s) will have to collect inputs and feedback from city planners.

- The consultant will work with AMC and city planners to identify the key criteria and capacity building for city planners for green development and neutral/low carbon cities.
- The consultant will design, and facilitate and provide support to consultation sessions with city planners organized by AMC.
- The consultant will analyse the consultation findings, feedback and draft guideline framework to be shared with AMC and FES for feedback, comments, and input.
- The consultant will review and incorporate the suggestions to complete the guideline, regarding choose of language and clear messages, and format.

Expected outputs

- Output 1: Outline of paper is drafted and consulted with AMC and FES
- Output 2: 1st draft of guideline with inputs and recommendations
- Output 3: Final guideline
